The subject is a 9.6463 acre corner lot with a vacant office building, open land, and retention pond. The parcel is rectangular in shape, and approximately 300' x 1200' on the corner of Pine Ridge Rd. and Old South Way. Old South Way is a dead end street that leads to the gated 55 and over mobile home community called "Lee Plantation". Originally the subject building was used as the sales center for this community that was developed around 2000. From the office building on the corner down Old South Way to the development, on the north side of the road, is the subject parcel which is long and narrow. There is a retention pond that looks to be approximately 1 acre and bisects the parcel.

The office building was built in 1990 and is reported to have approximately 1680 finished square feet of office with wrap around porches and a carport. The building appears to be vacant. The tax records report wood frame construction, and four bathrooms. The building appears to be "dated" and the roof looks to be toward the end of its life, with some of the exterior siding showing signs of deterioration. The existing structure adds no value to the parcel and would most likely be torn down when the site is eventually developed.

The tax assessment value of the property is \$221,609 from 2015. The taxes are approximately \$3610. The zoning is C1-A per the tax records. The lender reports the zoning to be mixed, with 2.4 acres C-1A, 6.4 acres RM-2 for residential, including multi-family, up to 15 units per acre, and AG-2 for the remaining. The highest and best use appears to be for mixed development, with commercial at the corner of Pine Ridge, and residential along Old South Way. A typical development plan may include townhouse style condominiums built on each side of the small lake. The property is located in an AE flood zone.

There are very few similar comparable listings and sales due to the uniqueness of the subject parcel and improvements, therefore a wide range of properties, both improved, and vacant land, were considered during the due diligence process. The comparables selected were considered the best available.
